

MEMORANDUM OF UNDERSTANDING



GOVT. COLLEGE CHAMBA, HIMACHAL PRADESH, INDIA and GLOBAL FORUM FOR SUSTAINABLE RURAL DEVELOPMENT (GFSRD), INDIA

This Agreement (hereinafter referred to as the "Memorandum of Understanding") is made and executed on 14th June year two-thousand-twenty-two (14- 6 -2022) by and between:

- 1. Govt. Degree College Chamba is one of the oldest premier educational institutions of Himachal Pradesh. The college was established by the Govt. of Himachal Pradesh on 15th May, 1958 as a co-educational college in the historical Akhand Chandi Palace with handful students and teachers and it is located in the admist of historical Chamba town. The college is presently celebrating more than six (6) decades of excellence of imparting education in the aspirational district and providing quality education to the youth across the district. The college is fully financed by government of Himachal Pradesh and is recognized by UGC New Delhi under section 2(f) and 12B of UGC act 1956. Govt. Degree College Chamba was accredited with Grade "B+" by NAAC in September 2015. The college has a creative team of 51 faculty members working tirelessly for more than 4500 students of under graduation, post-graduation, vocational and professional categories (hereinafter referred to as "FIRST PARTY" or "PARTNER INSTITUTION").
- 2. GLOBAL FORUM FOR SUSTAINABLE RURAL DEVELOPMENT (GFSRD), is a platform for Academicians, CBOs/ NGOs and Policy Makers formed with an aim to bring and link Rural Development Research, Policy and Practice in one umbrella and lead advocacy for Sustainable Rural Development globally. It is an ISO 9001: 2015 certified Not-for-Profit Company registered under Ministry of Corporate Affairs, Government of India. in this matter represented by Dr. Jayanta Choudhury, in his capacity as Founder, GFSRD, India, and therefore legally acts for and on behalf of GLOBAL FORUM FOR SUSTAINABLE RURAL DEVELOPMENT, (hereinafter referred to as "SECOND PARTY" or "GFSRD).

PARTNER INSTITUTION (GOVT. COLLEGE CHAMBA) and GLOBAL FORUM FOR SUSTAINABLE RURAL DEVELOPMENT shall collectively be referred to as the "**PARTIES**" and individually as the "**PARTY**".

The **PARTIES** agree to enter into cooperation for the implementation of different academic programmes aiming to develop capacity of existing faculties, involve students/research scholars in different personality development programmes prepared and designed mutually in broad areas of education, research, and community service etc. as per the terms and conditions of this MoU.

This Memorandum of Understanding is followed up by the PARTIES in the form of a Cooperation Agreement which is agreed upon and signed by the PARTIES and appoints technical implementers as the implementers of the cooperation according to their respective duties and functions fixed at the initial stage and being mend from time to time with mutual agreement of both the parties.

This MoU shall be valid for five (5) years from the date of execution or can be reconsidered mutually. The extension of MoU further will be based on the mutual consent of both parties.
